# 3.0 Priority Items

# **3.1 Standing Orders Amendment**

**SM1705/02** – Motion that the ECU Student Guild amend Clause 16 of the Standing Orders, by the inclusion of a new sub-clause, that states the Immediate Past President and the Guild's CEO shall be accredited observers for all Guild Senate and Guild Secretariat meetings.

## **Description:**

The ECU Student Guild is bound by legislation and rules in respect to governance and operational obligations as they relate to delivery of member services. Senators change each year and for many elected representatives it is the first time they find themselves having to understand the duties, responsibilities and accountabilities, and liabilities their positions have.

Although the Senate's role is one of governance (i.e. they determine the strategic direction of the Guild through the identification and approval of strategic plans and core policy, and financial management through the ratification of the annual budget), this can be daunting and it is important each the Senate utilises available resources to assist them in reaching ethical and logical decisions moving forward.

The immediate past President has a wealth of experience to help a new Senate, particularly in respect to the intricacies of student representative duties and maintaining valuable relationship building with the University and other stakeholders.

The Guild CEO heads up the salaried operational arm of the Guild and provides extensive business and governance management skills to ensure protection to the Senate in respect to adherence to rules and legislation.

Both of these people need to be a inclusion in each Senate and Secretariat meeting to provide each new Senate with relevant information and Guidance, in an advisory capacity, to allow them to make informed decisions. The risk of the alternative is a constant reworking of process to undo decisions, made without relevant consultation, which can prove costly to the Guild and its members.

#### **Discussion:**

Sam states that this Motion does not force the CEO and Immediate Past President to actively be at each Senate Meeting, only that they be invited to each one. Aqila states that she doesn't believe it is necessary as she found it to be confusing when both the Immediate Past President and CEO were at the Senate Meetings at the start of the term.

Caitlin queries Aqila why she found them confusing, as the information they provided wasn't incorrect, the Activate Senators only chose to believe that it was.



Aqila once again reiterates that she doesn't believe it is necessary, and Sam rebuts that if the Motion were carried, then it would prevent new Senators being misinformed about Guild Policies and Procedures, and would only be enforced if there was a repeat of what happened at the start of the 2017 term.

## 4.2 SSAF Recommendation Amount

Sam wants to recommend the Guild asking for 100% and cutting the fee charged to students in half. Brett advises that doing this would prevent any growth for the Guild. Sam argues that the University will never give us any more money so it's more just the Guild taking a stance that students would be charged less.

Caitlin suggests that we offer to take on more activities such as Uni Games and Conference Week with the increased funding. Brett believes that if we approach it with a compelling justification that they could potentially give us more than the minimum 50% and that we shouldn't write their answer off and propose something that is definitely not possible.

Sam suggests keeping \$1.9 mil increasing with CPI even if that's over 50% and the University gets the remainder.

#### 4.3 Senate Vacancies

The Senate will vote on the positions at the June 2<sup>nd</sup> Senate Meeting.
