# 2.4.6 Environmental Sustainability Officer

Kelsey reports she has been advocating for the Beeliar Wetlands and engaging with students off campus and at Mount Lawley. She has been acting in her capacity as an NUS delegate and promoting the National Day of Action which is coming up on the 29<sup>th</sup> of March. It is a student rally that is held in the CBD of Perth.

### 3.3 Reimbursement of Costs

**SM1703/03** – Motion that pending submission of receipts, the ECU Student Guild Senate approve the reimbursement of legal costs to the Guilds CEO, Brett Callender, currently amounting to \$4,029.60, which were incurred as a result of the CEO having to defend his workplace rights against an attempt by Senate members to terminate his employment for allegations of serious misconduct.

### **Substantiation:**

- The Senate acted outside its authority, breached due process defined in the Guilds
   Enterprise Agreement and denied Brett the principles of fairness and natural justice
   when they supposedly terminating him while he was on sick leave for Worker's
   Compensation due to workplace stress.
- Because of the Senate's actions he was forced into a situation where he had no choice but to seek legal support to protect his livelihood.
- The reasons for the supposed termination; were baseless and unsubstantiated.
- In their formal response to the Fair Work General Protections claim, the Guild acknowledged and accepted all statements of defence; as well as, the listed remedies, confirmed the claims against Brett were unfounded.

Please note, if the Senate choose not to ratify this motion the cost to the Guild will be much higher should Brett be forced to take the matter to the next level.
