Stewart: O'day. Was a really poor day. Rained most of the day and the smaller setup made it barely worth doing. Stewart thinks that we should go back to the old format next year.

Greg: Disagreed, pointing out that many of the schools are now focusing on course inductions of 50 to 100 students rather than the very large ones of the past. They are also spreading those inductions over the two Orientation Weeks so there won't be as large a mass of students available on O'day any more.

Discussion should be held with all the schools regarding their plans and working out how the Guild can supplement them.

Greg also suggested working with the Schools and groups like 1902 to make up Guild bags with materials relevant to students going through orientation.

3.6 - Office Bearers Reports

3.6.1 - President – Stewart

July was a busy month for the Guild. The Mt. Lawley campus is within an electorate that was due to vote in a federal by-election - Perth. As part of my ongoing plan to make sure the Guild is engaging and representing students on national issues as well as on campus-level ones, the ECU Student Guild in partnership with the Curtin Student Guild decided to hold a candidates' forum with a focus on youth issues. After a considerable number of hours by both me and the Curtin Student Guild President Liam O'Neill, several conservative and/or right-leaning candidates opted not to attend. The initiative was subsequently called off, but the groundwork has already been done. This may, in the end, be useful later in 2018 with a snap federal election increasingly likely. I intend for these events to be used to engage students on issues that affect them, alongside enrolment drives with the Australian Electoral Commission, and campaigns on issues such as housing, higher education, and wages. This goes to our core as a student union.

I have continued to engage several stakeholders at the University with regards to a waste-reduction initiative endorsed in-principle by the Senate earlier in the year. This has been to ensure that people with disabilities are not left behind because of any straw-phaseout the university undertakes, and to ensure that the Guild and the University are working together to increase access to reusable bottles as part of a single-use plastic phaseout currently underway.

Alongside the General Secretary and the Vice-President (Social Activity), I have been working to ensure that our Building 22 café proposal continues to progress. This includes back-and-forth discussion with our contractor to ensure that we are getting a product that will serve the needs of students and be something that helps us to expand our budget and, by virtue of that, the services that we can provide to students.

I started to look at how we could expand the number of FTE hours available for the Guild Student Assist service and, with an expansion of office space, what such an expansion would look like. Some ideas include the setup of an ECU Food Bank to assist students in hardship, increasing our ability to provide general industrial relations advice,

or allocating more time to help students who are struggling with, for example, housing or the Department of Home Affairs (formerly Department of Immigration).

Again, with the General Secretary and key stakeholders from ECU Strategic & Governance Services, I drafted changes to the ECU Student Guild Constitution for consideration by members.

Further, as the Senate is aware, I have continued to be heavily engaged in several issues affecting the Guild internally, such as ongoing disputes regarding human resources. I will continue to update the Senate as this progress.

3.6.2 - General Secretary – Greg

Over the last month I've been dealing with a lot of HR matters.

I've also been preparing for the SGM where we will be proposing a new Constitution to the members. I've been going through the new document and writing detailed comments on each change with an explanation for their intent, to hopefully make it easier for Members to understand the changes, but also to make sure future Senates will know exactly what the intention was behind each change when interpreting the Constitution.

I've also been working on moving the tender for the building 22 café/bar along. We will be meeting with Suburban tomorrow to discuss their current plan and budget, and have plans to take the plans to the University next week.

I'm working on the Schedule of Delegations and Authority. This is a fairly massive task to get started (as the previous one is completely inaccurate and many of the "delegations" within it are prohibited by the Constitution. I've been going through every Guild document which may provide delegations such as the Constitution, the EA, policies, and the motion registers (or minutes where registers aren't available) looking for delegations.

Unfortunately, records keeping of some previous Senates was extremely poor, and also, we only have records of minutes going back to 2002. I am going to assume that there are many activities that Senators or Departments currently do without any record of a specific delegation of that authority. As such, it might be a good idea for us to set out explicit delegations to bodies such as the Secretariat in a Senate motion at some point.

Fortunately, the Guild only allowed delegation to the Operations Manager from 2016 and records keeping since then have been better, so we can easily establish the validity of delegations made to the Operations Manager.

I also attended a meeting of the Postgraduate Studies Department as Executive Officer.

Although we would like to run an event similar to what we hold in the metro campuses, it is proving to be challenging and we have therefore had to postpone the event.

4.0 – PRIORITY ITEMS

4.1 - Discussion regarding membership register and the rules surrounding them

Stewart: Stewart raised concerns that some Senators may have been using the Membership register for non-Guild means. He reminded the Senate that the information contained within the register was confidential and should not be used for private purposes under any circumstances.

4.2 - Discussion regarding GSAs

Stewart: Stewart said that currently the Guild did not have full coverage for all the appointments for GSA's and this was causing massive wait times for Members with issues, which are often time sensitive.

Stewart explained that due to not having a front-desk/bookstore clerk, the Guild had funds available to pay to have another GSA for two days a week for the remainder of the year. He proposed offering Caity those 2 days at Joondalup, using the meeting room as an office for the remainder of the year.

4.3 - Discussion regarding Senators manning the front desk of the Guild

Greg: Greg suggested that the Senate consider altering the terms of engagement of General Senators, the International Officer, and the Environmental Sustainability Officer to move from an honorarium to a casual role with a wage, with each position having 10 hours a fortnight rostered time. In the short term, he suggested using Senators to man the front desk of the Guild during office hours to reduce the amount of time staff spend on inquiries to the detriment of their other duties.

He pointed out that currently the VP-A was now using a portion of their budget to offer non-elected officers of the Guild in their Department an honorarium comparable to the one offered to elected Senators. Additionally, the Guild currently hires casual labourers who are paid hourly wages.

Greg then explained that while the Postgraduate Officer position was vacant, the Senate had agreed to pay the Postgraduate Officer 10 hours per fortnight, and this had worked well with Joel once he took the role. Joel had currently attended all University Committee meetings, run monthly Postgraduate Studies Department meetings, in addition to his other duties under the scheme.

Greg went on to point out that currently the University runs many events aimed at International Students (typically each school runs multiple such events each semester, and the Uni also runs such events). If this is added to the events for International students run by the Guild, the same arguments in favour of paying the Postgraduate Officer hourly would equally apply to this role.

The Southwest Officer also has large time commitments which are not effectively renumerated.

Finally, Greg pointed out that typically changes to the pay conditions for Senators is set at the end of a Senate term for the incoming Senate, so that any perception of conflict of interest regarding changes to Senate remuneration would be mitigated, and he suggested the same be done again if any changes were to be made.

Stewart: Stewart pointed out the issue of Senator Honorarium's is a very common issue and is raised most years at around this time.

Greg: Greg responded by pointing out that this time there was actually a case-study in place with the Postgraduate Officer position, and that, in his view, the case study was successful.

Stewart: Stewart then pointed out that given the lateness in the Senate Term, that it was likely not worthwhile training Senators to cover the front desk and bookshop and actually hiring an employee to handle the role would be a better move.

Greg: Greg conceded this point.

Caitlin: Caitlin pointed out that any such switch from honoraria to wages would need to be paid for, and the Guild had a limited budget. She also pointed out that the Guild positions were meant to be volunteer positions and should be treated as such.

Greg: Greg acknowledged that finding the money to pay for the wages would involve adjusting the budget and this may lead to reductions in service in other areas, but argued against Caitlin's second point.

There is no element of the Act, the Statute, the Rules, or the Constitution which says that Senator positions are voluntary. There isn't even a current Guild policy which states as much. In Greg's view, the idea that Senator roles are intended to be voluntary seems to have been perhaps a view of certain members of the Guild or their employees but, to his knowledge, this has never been an official position of the Guild approved by either a Special Majority of Senators or Members at a General Meeting. As such, the consideration of any voluntary nature of Senate work can only be considered to be persuasive and not binding in any way on the Senate.

Greg then pointed out that Senators are paid at an hourly rate below that of casual staff who are employees when those Senators are paid a wage, again under this notion of Senate positions being voluntary. So it would actually be cheaper to hire Senators to do tasks like packing Guild bags, setting up fencing at parties, or running the BBQ at Guild events than employing casual staff to do the same job.

Stewart: Stewart pointed out that there may be legal issues involved, as in the past Brett Callender had intimated that only casual employees would be covered by the Guild's insurance.

Greg: Agreed it would be worth checking, but thought the whole notion that Senators are not employees of the Guild was a legal nonsense. If Senators are getting super contributions for their honorarium he strongly doubted that they were not considered legally to be employees of the Guild on fixed-term contracts, as such, they would be covered by the insurance.

Discussion was tabled, pending further research into the issue.

4.4 - Motion that the Guild support Flinders University Student Association's Be A Better Human Campaign

There was some discussion about what this campaign was about. Eventually it was determined that the campaign is essentially Flinders Uni Student Association running a campaign of support for the findings of the **Respect, Now, Always** initiatives and aimed at teaching students about consent.

After discussion, the Senate agreed that they agreed with the aims of the campaign, and there was no downside to offering a statement of support for the initiative.

Caitlin explained that she was going overseas in September for two and a half weeks. Octoberfest is on during this time.

As Harri is a licensed bar-manager she suggested having Harri run the event while she is away and suggested providing Harri with pay from the money set aside for her wages while she is overseas.

Caitlin wanted to give 60 hours for one of the fortnights and 20 hours for the remaining time to Harri so he can run the event and plan for it.
