# 4.2 – Motion- Edith Cowan College – Guild associate membership to be offered

#### Motion: SM1908/03:

To direct the PAC to complete a Membership and Facilities Services Policy in accordance with the preamble and permit ECC students to be associate members of the Guild for an annual fee of \$50 for the full year, \$30 per semester from the year 2020, and \$25 for the remainder of the 2019 term.

Motion carried unanimously with 1 abstention – Seema Behrami

Abhishek has mentioned that ECC coordinator, Amanda has spoken to him in regards to the ECU Student Guild to promote their events. Therefore, any VP's who would like to approach her can do so to help promote their individual events.

Seema Behrami enters the meeting room in the middle of discussion at 10.32 am. Senates agreed that associate members will be included in the mailing list for monthly Guild newsletters for event updates and promotions from external providers. Senate agreed that a Membership and Facilities Services Policy has to be created before starting of registration for association membership. Senates agree that associate members can sign up as members for clubs in ECU. Melissa has also advised that there will be an associate membership card issued to the associate members who are not students of ECU. It will be confirmed if the cards will be rolled out and reactivated for this new purpose. Elsa raises a question of the misuse of kitchen facilities by ECC students who are not associate members as associate members bring their friends along. Therefore, the senate came to a decision to find a way such as making associate

members have their associate membership cards available for viewing at all times by wearing it on their land yards and also having random checks here and there. Also, a warning or fine of some sort will be issued to those who are not of associate members. Melissa also suggested that a yearly semester sticker will be issued to the associate membership cards to ensure a correct and accurate record of members who have purchased their membership. All senates are aware of issues raised above and are in agreeance to resolve them through the use of a policy.

# **4.3** – Motion- Motion- Affiliation of the ECU Student Guild with the National Union of Students (NUS)

**Motion: SM1908/04** 

The ECU Student Guild will affiliate with NUS starting from August 2019 to August 2020 and pay the membership fee which has been reviewed and is well within budget.

Motion moved unanimously

Georgia has asked if the Guild owes any outstanding payments to NUS, Abhishek replies to her saying that we do not owe them any outstanding payments. Abhishek has proposed that if the Guild affiliates with NUS, we will then need to pay the membership fee which is in within the budget. Once paid, the membership will then proceed for 12 months. Abhishek also explained a little about his experience with NUS. Such that they hold workshops, campaigns and protest in and among Australia Universities. He has explained that NUS did have a few years of bad reputation but in the most recent years, they have been keeping up to date with any records and have better aligned to the focuses that the Union has set out to achieve. Also, they have reviewed their actions and have been in better circumstances now with most Universities. Abhishek confesses that he was disappointed as he couldn't attend a few campaigns which would have potentially help the Student Guild in regards to lobbying the University to reduce prices for student housing and also another campaign in regards to sexual harassment and bullying. This was because the Guild was not a member with the NUS in the past months and therefore did not receive their services. He has also suggested that it would be good for the Guild to affiliate with NUS as they are sometimes present in Perth and can represent student voices during Guild days with their booths and own marquees which is great for promotion and awareness. Abhishek also comments that most of the issues that the Guild is facing such as internet issues in student housings and everything else has already been happening or even resolved by NUS itself. Therefore, reemphasizing the huge learning curve.

#### 4.4- - Motion- Guild Affiliation Policy amendments under the Eligibility for Funded affiliations

#### **Motion SM1908/05**

The Guild Affiliation Policy is to be amended to include the following under clause 5.6 Eligibility for Funded Affiliation:

- "The Financial Controller & Marketing Officer must be a signatory on all club accounts."
- "The Financial Controller & Marketing Officer must have access of the club online banking and must be consulted of any changes made to the account or the online banking account, failure to provide this will automatically disaffiliate the club in question, until the FO and MO have regained access to both the club account and online banking."

#### Moved: Seema Behrami

Seema explains that there were lack of access by the Guild especially when students start graduating and do not handover their clubs to someone else. More so that operations staff have to go through a lengthy process sometimes to obtain invoices and receipts due to unapproachability of some clubs. Melissa also confirms the lack of access on her finance point of view and that in the long term is not good for the Guild. Georgia explains that she understands where the stand point of the Guild is coming from, but she also understands that some clubs would like to have the right and some separation in order to run a club independently. But supporting this, she feels that it would help both clubs and the Guild in the long run by making things easier and more efficient. Especially for Equity clubs who sometimes at a short amount of time would need to source stuffs for their equity members and cannot be delayed by lack of approachability of their executive committees. And for that it justifies the importance of having access to their bank accounts for an overall welfare of the club in general. Georgia also suggest that the senates from the new term will therefore need to hold a meeting maybe during the Clubs day to inform them of the changes and that they will need to include it in their constitution and consult both the FO and MO for signatory details. The senate agrees to this and has suggest that a template be used for clubs in the coming semester of the new term.

Melissa has suggested an amendment of words used in the motion to exclude 'and', and change it to 'or'. She suggests that one of either FO or MO, or both can be the signatory instead of limiting it to only both which in turns makes it difficult.

#### **Motion SM1908/06**

The Guild Affiliation Policy is to be amended to include the following under clause 5.6 Eligibility for Funded Affiliation:

- "The Financial Controller or Marketing Officer must be a signatory on all club accounts."
- "The Financial Controller or Marketing Officer must have access of the club online banking and

Georgia has raised a concern about the automatically disaffiliation in question of clubs who do not first consult the FO or MO in regards to any account changes. She has commented that it is not of appropriate use of words and suggest to change it to a less restrictive structure. Instead of automatically disaffiliate the club in question, she suggested a temporary suspension of affiliation which can then be reverted when issues resolved. The senate has agreed to the changes.

#### **Motion SM1908/07**

The Guild Affiliation Policy is to be amended to include the following under clause 5.6 Eligibility for Funded Affiliation:

- "The Financial Controller or Marketing Officer must be a signatory on all club accounts."
- "The Financial Controller or Marketing Officer must have access of the club online banking and must be consulted of any changes made to the account or the online banking account, failure to provide this will temporarily suspend the affiliation of the club, until the FO or MO have regained access to both the club account and online banking."

# 4.5- Motion- To appoint a new VP Social for the replacement of Alfred Koech

**Motion: SM1908/08** 

The Guild will appoint an acting VP social who will get a handover from Alfred, the current VP social and be under a probation period of 2 weeks. The performance of the candidate will then be reviewed by the secretariat in due time as successful or not successful to progress into a fulltime role of VP social.

Moved: Elsa Chew

Alfred was asked to speak IN CAMERA about his roles and responsibilities and moving forward, what will the new acting VP social have to be aware about and if they can handle issues that has been made notice to him. Abhishek opens discussion to the floor and suggest that any senator who is interested to take on the VP social role can raised their hands. Vimal and Raj has nominated themselves. Both Vimal and Raj were given a chance to speak on why they deserve the role. All other senators had a few minutes to ask candidates any questions which were then answered individually.

Both candidates were then excused from the meeting room. IN CAMERA discussion took place inside the meeting room, a secret ballot was held. Following this ballot, Melissa tallied the votes in front of the senators, and Rajesh was elected as the new acting VP social under probation of up to 2 weeks.

#### **Motion: SM1908/09**

The Guild will appoint Rajesh Kumar as the new acting VP social who will get a handover from Alfred, the current VP social and be under a probation period of up to 2 weeks. The performance of the candidate will then be reviewed by the secretariat in due time as successful or not successful to progress into a fulltime role of VP social.

#### 5.0 – DISCUSSION ITEMS

5.1 Senate office area of Guild/ Open plan space.

Senators have come to a conclusion that it is up to our sensibility, respect and responsibility of keeping it a safe workplace and somewhere to work with focus and confidentiality. There might be signs and safety ropes to be installed at the office open plan space which will be further discussed with Anthea, HR. Or, we might move some furniture around to restrict direct entry of students into senator working stations. Senators came to an agreement that they will be more responsible of who is allowed and accompanied by their relevant senators when using the office work stations. Georgia has also suggested that clubs can access a computer near the kitchen area for printing instead of having to come into the senator work space and to use one of the computers for printing. Melissa has agreed to get that in place. All senators are advised to consult with Anthea in regards to OHS before deciding on their decisions for restricting the open plan office space.

#### 5.2 Senate timesheets

Elsa has proposed that senators be more responsible of their timesheets especially with not submitting them on time or leaving descriptions blank. Melissa then reiterates that it is not good for record and will help make it easier when approving timesheets as it is indicated or justified in the description box. Also, just 'work' is not a clear description. Georgia suggest that senates can put in senate meetings, student appeals, office coverage as some example description for clarity.
