4.6- Motion-To take on another General Senator

Preamble:

Brian Njane has expressed his interest to the secretariat that he is interested in a general senator position with the Guild as of the rest of the term for 2019. His statement is attached in appendix 4 He has also been one of the considered candidates to take on the VP social role before it was opened up to the senate. He has actively contributed to the overall University experience and has ran for both elections in 2017 and 2018.

As the Guild has had a few senators such as Elsa holding 2 roles, and Raj resigning from his General Senator role, we are now down to 11 senate members in total. Namely, Abhi, Faizan, Seema, Raj, Elsa, Dago, Vimal, Georgia, Abbas, Ellen and Wakiini.

Taking on Brian will allow him to ease the workload needed during the busy event periods. He will be guided closely by Elsa and Raj to help him adapt to his role and will be paid the same as other general senators which is 5 hours' honorarium.

This will also help improve his overall experience and allow him to understand the Guild better. He will contribute to the overall senate and be of great asset to the Guild.

Abhi has asked why Ellen has abstained from voting, Ellen replied that she has never met Brian and does not know of his character or benefit to the guild enough to vote of this decision.

Raj has propose that Brian comes in today to get an introduction with the senate team as we are all present today if he successfully gets elected into the role.

Mel suggest that Anthea will have a welcome pack for him ready and will help him set up his employment hero whilst ensuring all documents are compiled and ready to go.

Melissa briefed the senate about the first ever OHS meeting ever conducted to comply with the OHS standards of the Guild after setting up a committee. They have been working hard implementing health and safety rules in the guild. Health and safety reports were done on all 3 campuses regularly. Also, they have discussed on how to work together with University to make the Guild a safer environment in respect to the security systems, the OHS compliance and hygiene etc. Not to forget that the OHS committee has put the GSA's in mind and observe their daily routine to ensure that the Guild improves on their safety when they engage with students on an individual level. Melissa also advices that the Guild has been researching on other avenues which will help improve on

Elsa has briefed the senate that Lauren has purchased merchandizes for 2020. Melissa then added that the budget would come out from the 2020 annual budget and thus, for purchasing of next year's merchandizes, it has to be done in 2019 as the Guild has to always plan ahead.

Elsa has urged the senate to provide her with office bearer reports for August and September 2019 by the end of next Friday so to keep track of things and task carried out by the senate.

6.4- Discussion on travel expenses

Preamble:

As secretariat members have a budget for conferences annually, Anthea has proposed that there should be some clarification in regards to spending that amount of money reasonably which is included in the employee handbook. (see appendix 5)

Discussion on this matter.

Melissa gave a brief that in the pass senate, secretariat has 13,000 to spend on a flat rate. Because of different places.

Now we are following an adhoc basis, and Anthea seems a little concern with this system and has suggest that we be more consistent about it.

There have been suggestions that the employee handbook include a guideline for reasonable travelling cost. Whereas, for airfare, operations can go on a separate calculation because of supply and demand as proposed.

But for hotels, there would therefore have a good guideline already ready for us to use and will then be updated yearly to fit the pricings of the economy.

The senate authorizes operations staff to propose a guideline for reasonable travel that will be included in the employee handbook for senators starting from the year 2020.

6.5- Disciplinary committee (DC)

Elsa has proposed that the DC has been mentioned of in the January senate meeting but has not been active since as there were no previous referrals of student to the DC.

Faizan advised that in January, the senate had proposed for 2 external personnel to sit in the committee but we will have to amend that criteria as in the constitution, it is suggestive that there has to be at least one senate member setting on the committee.

Melissa has also commented that we are mandated to have the DC ready for whenever there is a student needing to be referred to the DC. And that includes our own senators who commit any misconduct.

Seema suggest that we will need to amend the clause in regards to DC in the constitution or standing orders it if we want to make it generalized for all students because if a senate member gets referred to DC then what happens then?

Faizan suggest that we can include it in our SGM next year that we can propose to the new senate team who will take over after the elections in 2020.

Abhishek proposes that, if at any time, we have all senate who is of conflict of interest, then we can get someone external to sit on the committee. But if there is senate who is not of conflict of interest to the student being referred, then senate can sit on the committee.

Melissa advices that senate has to be sensible about inviting a justice of peace as one of the external personnel on the committee as the majority of them are full time in their work. Thus, we will need to rethink about who we want as an external personnel to sit on the committee if needed.

6.6- Senate meeting minutes from 2018

Preamble:

Senate meeting minutes from December 2018 April and May 2018 have been read through by secretariat after transcription and rewriting.

This has arisen due to the arguments of the accuracy of the 2018 minutes from the senate in 2019. There was some information in the minutes that were not discussed in the meetings and vice versa.

Elsa updates that the guild is looking at publishing it once sensitive and confidential matters are redacted. Also, the rest of the 2018 year's minutes will be ready by the next month or so which will again go through the correct processes and published on the Guild website when ready.
