4.2 – Clubs/Societies/Collectives

Preamble:

Clubs/Collectives and Societies are the core representation of the Guild as it is a student led organization. Thus, emphasizing the importance of ensuring that they are well trained and equipped to run events smoothly and also to manage themselves well throughout the year with budgets provided by the Guild. In previous years before 2019, the Guild has always made compulsory a club training day. This year, it is suggestive that there be 2 activities to help strengthen the understanding of running a Clubs/Societies/Collectives and also at the same time, allow students to better understand those who represent them. A club affiliation day will be held on the 18th of February 2020 to help all students who might be interested in creating a Clubs/Societies/Collectives and potentially affiliating themselves with the Guild. As there are 2 types of affiliation, basic or funded, students sometimes find it confusing and as both affiliations differ from one another in terms of what is required to be successfully affiliated with the Guild, this would be welcoming opportunity for everyone to learn and socialize. The other compulsory Clubs/ Collectives and Associations day would be the 'Club training day '. This would be compulsory for all clubs who have been affiliated successfully with the Guild. It will be organized on the 9th and the 10th of March 2020 with one day each at Mount Lawley and Joondalup. It will be a detailed run down from how to manage a club to how to budget for events and also to learn how to communicate with the Guild more effectively. This would be an approachable manner in terms of strengthening relationships with the community. There will also be a few drop in sessions in between those dates to help any students that find it difficult or would need extra help otherwise.

Lisa & Melissa discussed that last year we had 35 clubs in semester 1.

Elsa mentioned that there will be drop in sessions to teach how to run a club.

Jackson explained how clubs have expressed interest in running a session (law doing governance & finance doing budgeting).

4.3 – Mount Lawley representative

Preamble:

As students from ML have often voiced their concerns about being 'neglected' and 'isolated' due to its location away from Joondalup, and also the lesser number of attendees during events, the Guild feels that it needs more representation in the ML campus. With that said, because many of the senators are mainly based in Joondalup, and the Guild understand that ML student needs are vastly different to students in all other campus, thus, the suggestion of having a person or a group of representatives who will be the direct responders to ML student needs and are exemplary Guild representatives. The role will be a voluntary basis with a certificate of recognition at the end of the year awarded to the student of the group of representative at the end of the year. This will be a

good way to assist ML students led by ML students themselves. It will also be an opportunity to create a stronger connection to the campus culture itself which is significant like no other. A form stack will be created for nominations of ML representatives which will need to be students form ML themselves. They will then go through an informal interview with Elsa, Jackson and Lauren who will form an interview panel. The potential candidate or candidates will then be briefed about their roles and responsibilities and will report back to the Guild at all times. All in all, this initiative will mainly be to connect better with the ML students who are part of ECU.

Shakeeb asked if they are volunteers, Elsa responded yes and this could be a permanent senate position if it works.

Syed asked if they will have access to the office. Elsa responded no, they will not have access to the office. Syed & Elsa noted they are representatives not senate.

Melissa noted that we should reassess the amount of budget is being put into Mt Lawley. Lisa noted that this could be a useful trial to see what students there want but we need to factor in the VC's announcement about ML closing.

Syed suggested another motion that restricts how many & what they can do.

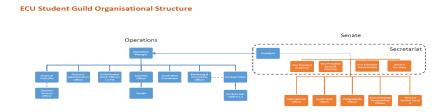
