Elsa and Jackson had agreed that they would either fit more into the academic or social category as it is catered to Social work international students which is very targeted and specific.

## 4.3. SM2008/04: Auditor Appointment

Pre mable:

The Guild is required to be audited under our constitution and ACNC requirements and is usually appointed at the AGM each year. At the 2020 AGM, due to time constraints it was resolved to re-appoint the current Guild auditors (RSM) provided their fee quote, to be provided, was within 10% of our previous year fee paid for our audit. We have now received the fee quote from RSM for the next 3 years and it is substantially increased by 52% from \$7550 for 2019 to \$11,500 average over 3 years for 2020-2022. Due to our ongoing budget constraints and we then sought expressions of interest and fee quotes from 10 other firms in Perth, who operate in this market, from 'Big 4' such as Deloitte and PWC to second tier firms. We received 2 declined responses, 4 positive responses with quotes, and 5 no replies. Of the 4 positive responses, Lisa and Melissa have met with 2 of the providers either in person or by remote online meetings and one other by telephone and found them all to be well qualified and suitable. The fee quotes are ranging from \$7,500 to \$8,500, being substantially less than the quote from RSM and include some add on services we would like to utilise.

One of the firms 'Moore Australia' (previously Moore Stephens), is the current Curtin Guild auditor and therefore has a very good understanding of how Guilds and universities operate together, as well as offering input on improvements and support to the finance function which can be well utilised, especially if operations staff turnover. Our second preference is Nexia Partners.

As such, we recommend appointing, Moore Australia, as the Guild auditor for 2020, 2021 and 2022 with the fees quoted of \$\$8,000, \$8,150 and \$8,300 respectively.

Melissa had given a run down about the differences in between each Auditors and why one was preferred over the other.

Elsa had clarified that her query was in regards to why Moore was first preference over Nexia but had suggested that it was already addressed by Melissa as she explained that Moore had worked with Guild's before and would have good knowledge of Guild structures and workings in within the Guild. Thus, the preference was made to have them as the top choice.

#### 4.4. Dircksey Regulations

Preamble

Following a review of the Dircksey Regulations by the Dircksey Editor, Shaun Salmon, a number of amendments have been suggested to ensure that the rules around engagement of Contributors, Sub-Editors and the recruitment of the Dircksey Editor are given more clarity. The regulations have been reviewed and updated in partnership with and are supported by the Marketing & Promotions Officer and the Operations Manager. The relevant changes are as follows:

- Revision of a maximum of 3 Sub-Editors to 2. This is to allow for budget to provide concessional payments to contributors in order to increase and incentivise student contributions to the magazine;
- Amendment to clauses in relation to limiting any kind of payment to contributors; and
- Adaptation of clauses in relation to the recruitment of the Dircksey Editor to allow freedom to recruit from outside the student body should a recruitment process not yield a suitable or any applications from students. This recruitment process from within the student cohort should be conducted twice before the regulations allow external recruitment. This clause will ensure that the Guild is always able to support the magazine regardless of student appetite for involvement in a leadership position. Lisa gave a detailed run down of how the decision had come about to have the Dircksey regulations amended to better fit the current structure of Dircksey.

Elsa further clarified that this process was transparent and well thought out. Her only concern is that recruiting outside of the student body would not be preferred as Dircksey is a student led magazine and should be prioritised for students at ECU first and foremost. She had then seek clarification on that the Dircksey editor will need to exhaust recruitment internally for ECU students in 2 accountable and transparent attempts before engaging external interest for the role of sub-editors.


