As there are discussions in regards to Clubs, Faizan has asked the observer Wouter Timmerman if he has any comments for the senate. Wouter has suggested 3 items to follow up from the Guild:

- 1. club and their best practice to share with each other
- 2. membership number of each clubs and what does better for attracting new members
- 3. affiliation template and how to run a club template

Wouter has suggested that the templates that are currently online is not as helpful and is not as sufficient to help clubs. Wouter has quoted and requested it to be minuted, "The templates available are not helpful and it is like the Guild is leaving the clubs to figure out about it themselves". Wouter has also suggested that it should not only be the Club's responsibility to contact their Vice Presidents but it should also be that the VPs reach out to ensure their club's are progressing and doing well as senate are 'paid for their roles and their time while the club members are volunteer roles. Faizan has responded to say that Vice Presidents do have responsibility of their department and their clubs but have suggested that if any clubs have reached out to their Vice Presidents but have not received a reply that the issue can then be alleviated to himself and Elsa (General Secretary). But the core responsibility will still lie on the hands of the clubs to reach out first if there is of an issue arising. Faizan also informed that the Guild senate are not paid employees and that the pay as suggested by Wouter is not for the role that they hold but instead it is for honorarium of their time contributed as volunteers of the student led organization. The Guild will keep active communication with clubs moving forward. Also, there are club policies that have been in the progress of updates and amendments as collated from student feedback so that will

be updated soon.

Faizan has taken note of the points suggested by Wouter and has thanked him for his feedback. He has suggested that he will follow this up with relevant senate on the points raised above.


